Statement for Inclusion in the Public Record

My name is Kirk Walder and I am a full-time resident of Zephyr Cove, Nevada. The comments that follow are my personal views.

I strongly support approval by TRPA of the Event Center. Starting construction of this facility is in the best interest of the greater Tahoe community and the plans proposed by the Tahoe Douglas Visitor's Authority meet the requirements of TRPA.

Planning for the future and balancing the needs of the Tahoe area should be your top priority. It is the job of government leaders to have the vision to see thru current conditions and show leadership in making decisions for the benefit of this region.

Our workers and businesses are now in the midst of a crisis. Everyone hopes the health issues will soon abate, but recovery will likely be uncertain and uneven. Building the Event Center is one action that will help in many ways. First, construction of this magnitude will employ many workers at a time when unemployment may be surging. And the businesses that serve those workers, such as food service and transportation, will certainly benefit. Many of these are small businesses who might be forced to shut down without the potential of new customers.

As visionary leaders, I hope everyone on the TRPA will recognize that the world and our region are likely to change in many ways. Working at home will increase and business travel will decline. The impact on vehicle traffic in our region is likely to be significant. Please think forwardly and not make decisions based on past behavior and data.

The Event Center has the potential to improve employment in the region in an important way. By concentrating activity during the shoulder season and weekdays, it will increase wages for individuals who currently struggle at certain times. Providing those workers a better economic future will benefit this area greatly.

TRPA should always look at issues from a regional perspective, but I would ask those from California and non-Douglas County areas of Nevada to respect the support of the Event Center by Douglas County elected officials. This project has been consistently supported over many years by the Douglas County Board of County Commissioners.

I applaud your efforts to move forward on this matter in these challenging times. I look forward to joining your meeting remotely and hope to forward additional comments as I review your discussion.

The March 18, 2020 Staff Report has numerous sections that raise questions or concerns. I hope these will be carefully evaluated as this project moves forward.

On page 6, concerning parking, the report states:

4) No "in and out" privileges for day users using the parking lots. Overnight visitors will be allowed "in and out" privileges.

Assuming this includes the parking lots at the casinos, I believe this would severely handicap the restaurants and shops at those facilities.

On page 7, concerning transit, the report states:

1) Continuous daily service year-round in a service area between the Round Hill, NV area on the north and the Bijou Center, CA area on the west, including a one-way loop around Pioneer Trail, Ski Run Boulevard and US 50 (See Appendix A of Permit Attachment A for transit service area).

Demand for this service would seem limited from the Round Hill, NV area and would add significant costs in transportation time and miles traveled. Given the availability of parking near Kingsbury and RT 50, perhaps begin transit at that location.

3) Fixed route will run between Montbleu and Round Hill Pines Beach Resort.

This would increase transit cost with questionable benefits. Is the Event Center transit designed to transport people to Round Hill Pines Beach Resort? Should service also then go to Nevada Beach? Zephyr Cove? Each of these already has paid parking.

On page 8, the report states:

8) To generate additional funding for transit enhancements, the applicant will require that the operator of the Event Center include a surcharge of \$4.00 for each participant contracted or ticket issued for every Event Center event. At least 75 percent of the surcharge shall be dedicated to transit enhancements above and beyond the transit operations required by the Adaptive Management Plan (Attachment A). The funds collected may be used to further reduce the VMT generated by the Events Center. The applicant may use up to 25 percent of the surcharge for post project monitoring.

A surcharge of \$4 not only could reduce the success of larger events, but would unfairly penalize those smaller groups using the Event Center. Is it desirable fo charge a \$4 per person fee for a civic group of 50 that holds a 2 hour meeting? The purpose of the Event Center should be to encourage its use, not propose costs for community functions.
