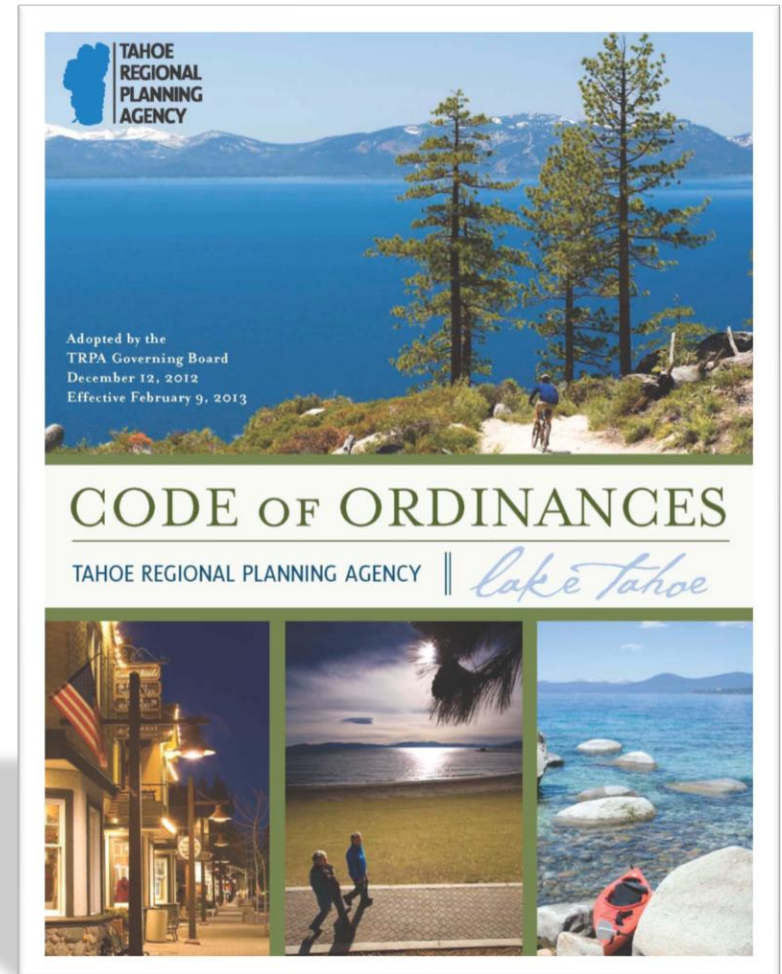

# Code of Ordinances

- Centralized collection of regulatory ordinances
- Major revision with Regional Plan update in 2012.
- Last technical update: October 2017
- Recent revisions:
  - Development Rights
  - Shoreline Plan



# Approach

- Purpose: Routine maintenance of Code of Ordinances
  - Address errors and inconsistencies
  - Clarify existing provisions
  - Reflect current practices
- Collected technical correction proposals from staff
  - During screening, two proposals were identified that involve a change in policy.

- 1. Technical Amendments:** 44 changes affecting 18 chapters

# Technical Amendments

- Corrections and clarifications with no change in policy
- **44** amendments affecting **18** chapters
- Amendments fall into the following categories:
  - A. Updating references, correcting errors (6)
  - B. Adding references to Area Plans (12)
  - C. Clarifying residential density (1)
  - D. Development Rights corrections (6)
  - E. Shoreline Plan corrections (19)

# Technical Corrections

## A. Updating References / Correcting Errors

...the scenic ratings per the adopted Scenic Quality ~~Implementation~~  
Improvement Program and Technical Appendices (SQIP)...

## B. Adding References to Area Plans

### Local Plan

An adopted Area Plan, Community Plan, or Plan Area Statement

...TRPA may adopt area-wide specific plans or project-oriented master plans to augment local plans ~~area statements or community plans~~.

# Technical Corrections

## C. Clarifying Density

The maximum densities established in Section 31.3 may be exceeded for projects located in the Town Center, Regional Center, and High-Density Tourist District Overlays in approved Area Plans pursuant to Section 13.5.3.

## D. Development Rights Corrections

A deed restriction shall be recorded with TRPA and the local jurisdiction ensuring that the units remaining in the project area meet TRPA's affordable, ~~or~~ moderate-income, or achievable housing definition and shall be so maintained





# Technical Corrections

## E. Shoreline Corrections

Coverage attributable to these adaptations is allowed pursuant to subsection 30.4.6.D.3.a.



# Substantive Amendments

## Chapter 50

- Topic: **CFA allocations to special projects**
- Currently awarded based on inclusion of projects that address thresholds that were in non-attainment in 2001.
- Proposal: Delete reference to 2001 report.

## Chapter 63

- Topic: **AIS inspection and decontamination**
- Currently, ordinance only subjects watercraft to inspection/ decontamination.
- Proposal: Expand to include tow vehicle, trailer, and other ancillary equipment.

# Recommendation

## Adoption of motions to:

1. Recommend approval of the Required Findings as described in Attachment D, including a Finding of No Significant Effect, for adoption of Code Amendments; and
2. Recommend adoption of Ordinance 2019-\_\_\_\_\_, amending Ordinance 87-9, as previously amended, to amend the Code of Ordinances as shown in Attachments A, B, and C.
